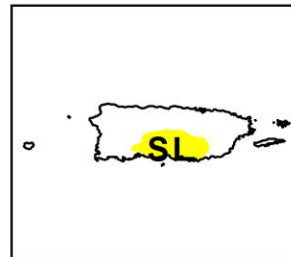
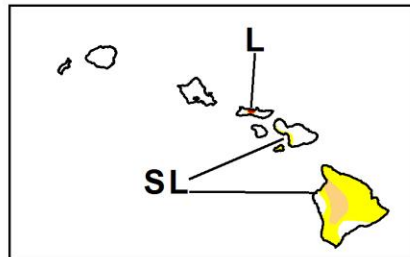
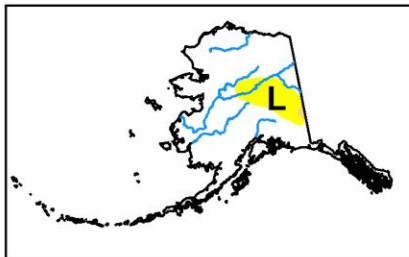
**Drought Impact Types:**

- ~ Delineates dominant impacts
- S = Short-Term, typically less than 6 months (e.g. agriculture, grasslands)
- L = Long-Term, typically greater than 6 months (e.g. hydrology, ecology)

**Intensity:**

- D0 Abnormally Dry
- D1 Moderate Drought
- D2 Severe Drought
- D3 Extreme Drought
- D4 Exceptional Drought

The Drought Monitor focuses on broad-scale conditions. Local conditions may vary. See accompanying text summary for forecast statements.

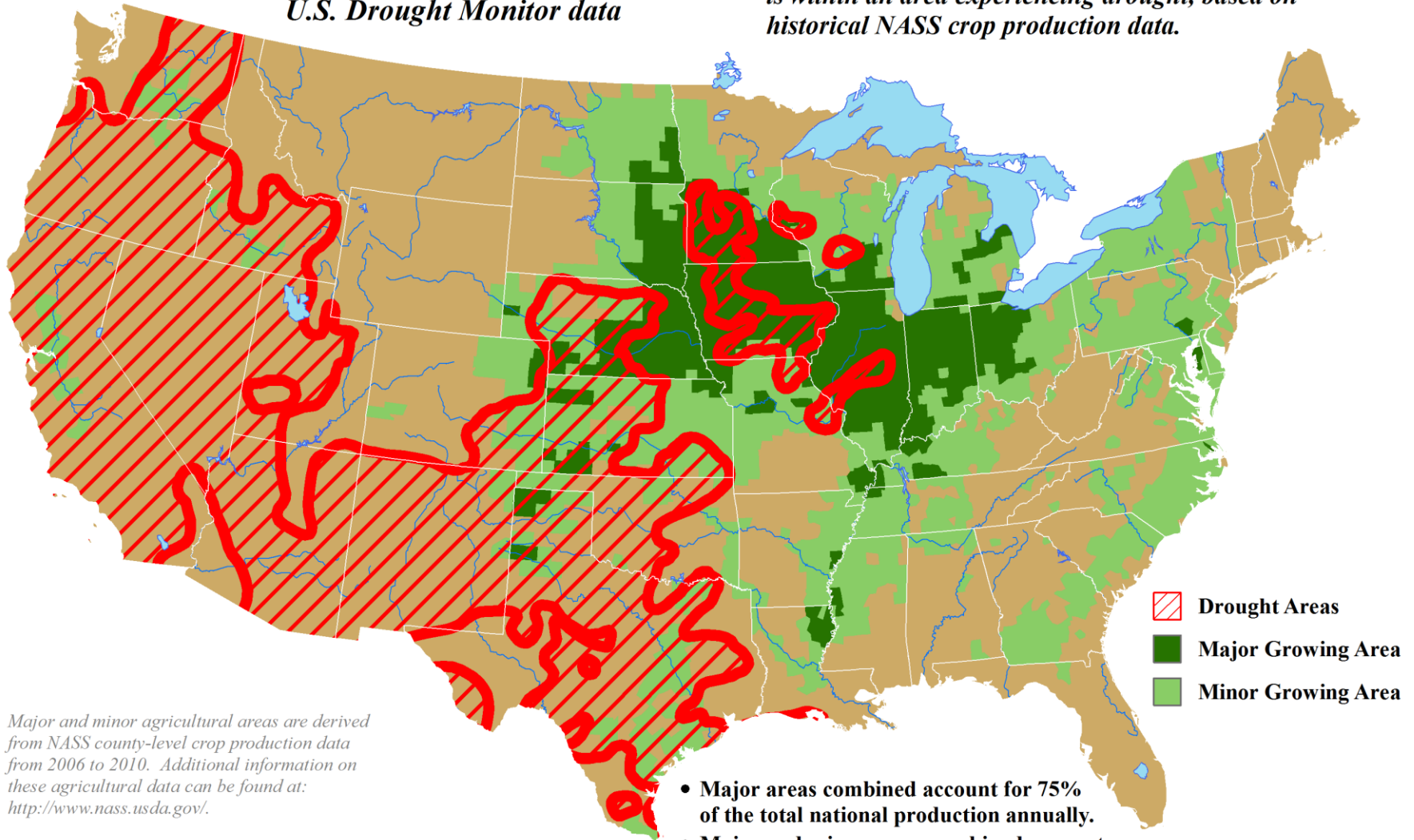

historical NASS crop production data.

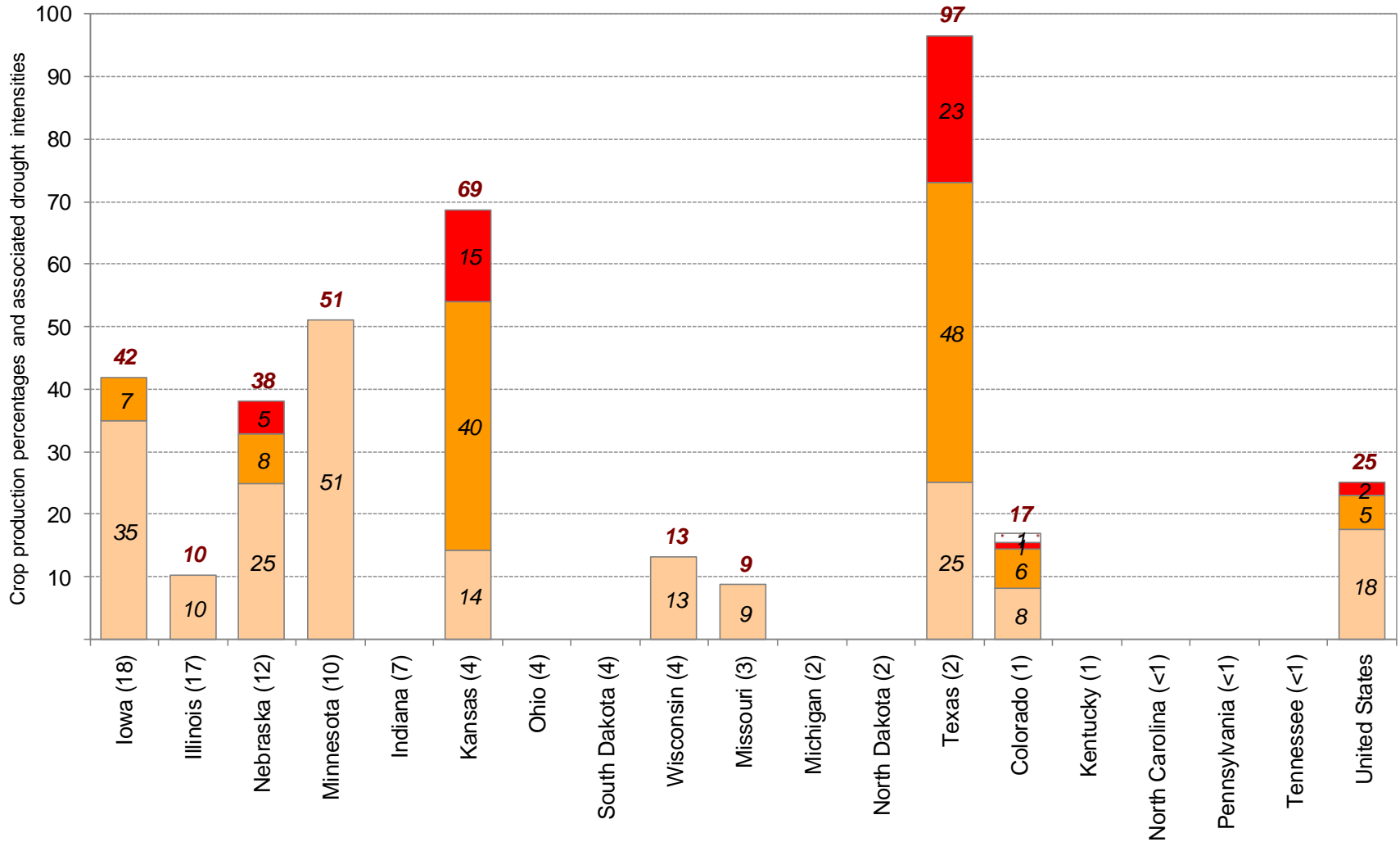

## Approximate Percentage of Corn Located in Drought \* March 4, 2014

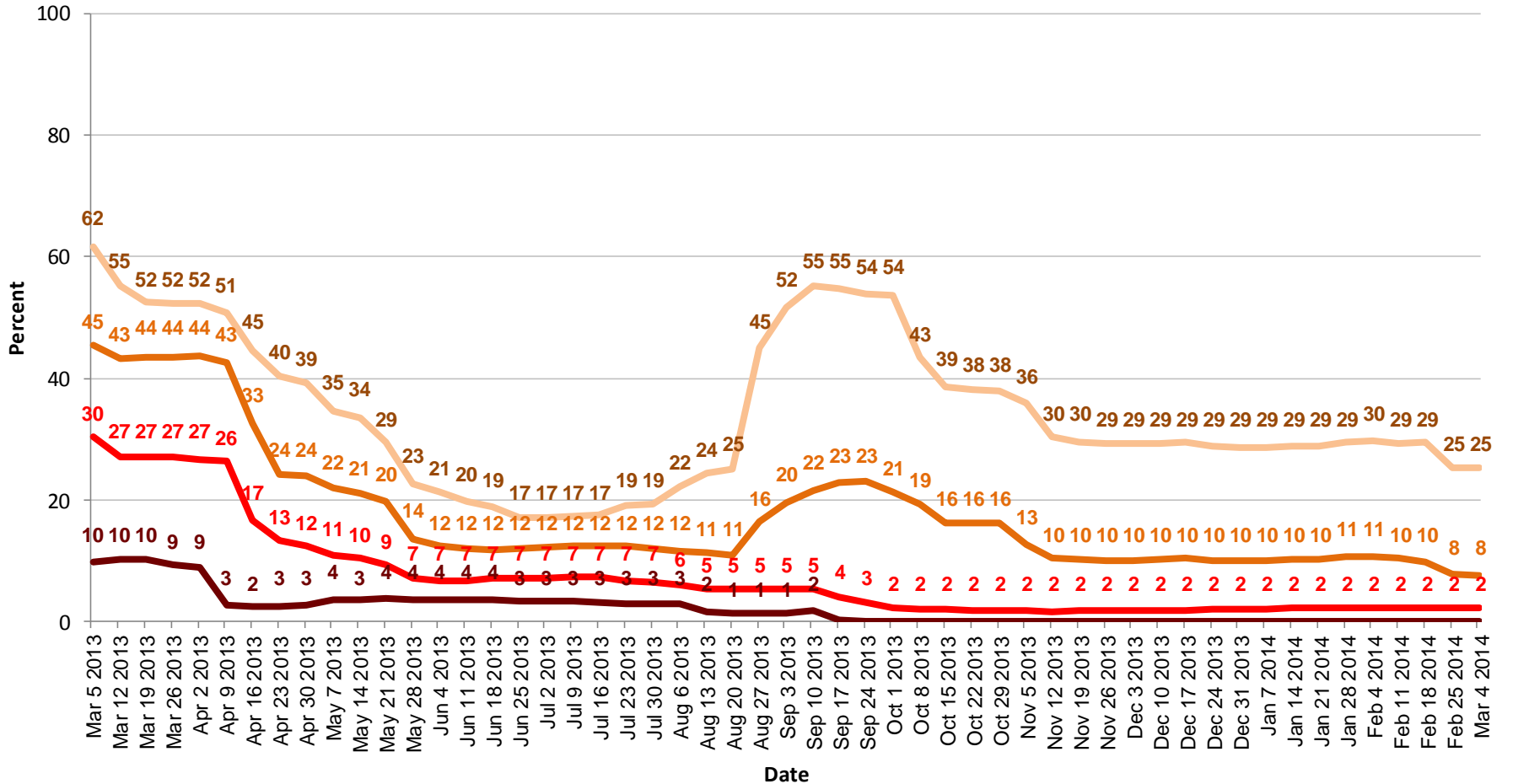

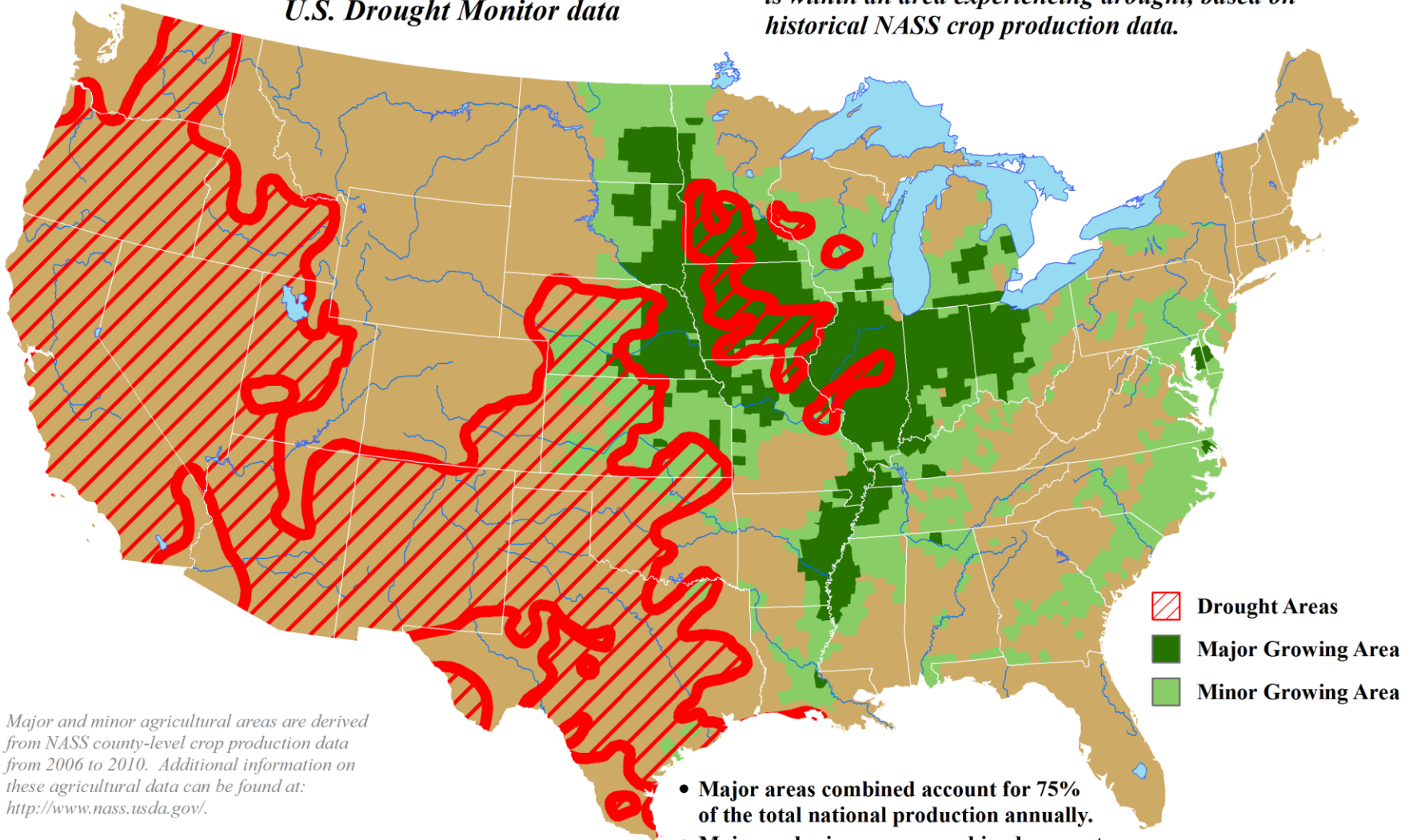

Approximately **17%** of the soybeans grown in the U.S. is within an area experiencing drought, based on historical NASS crop production data.

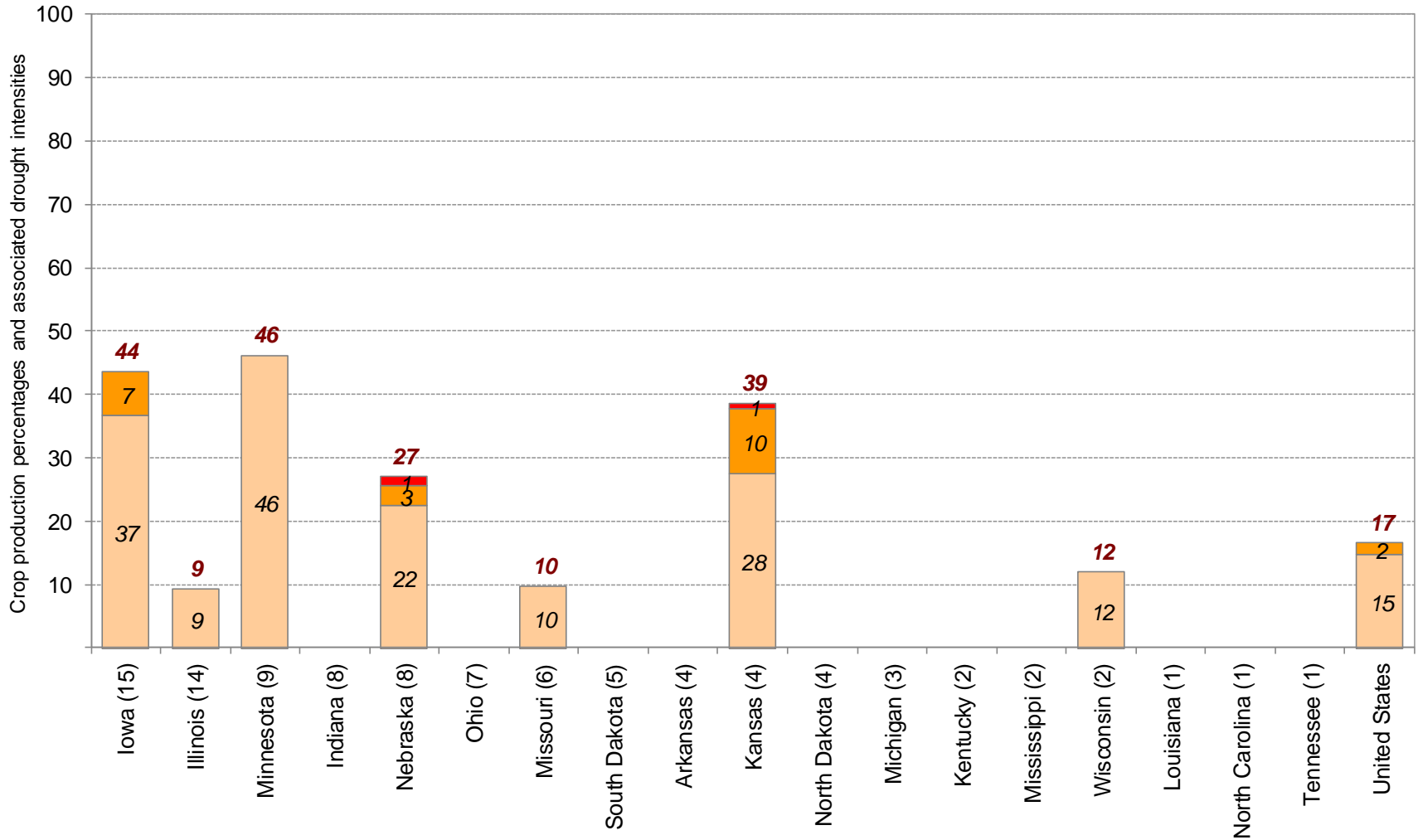

## Approximate Percentage of Soybeans Located in Drought \* March 4, 2014

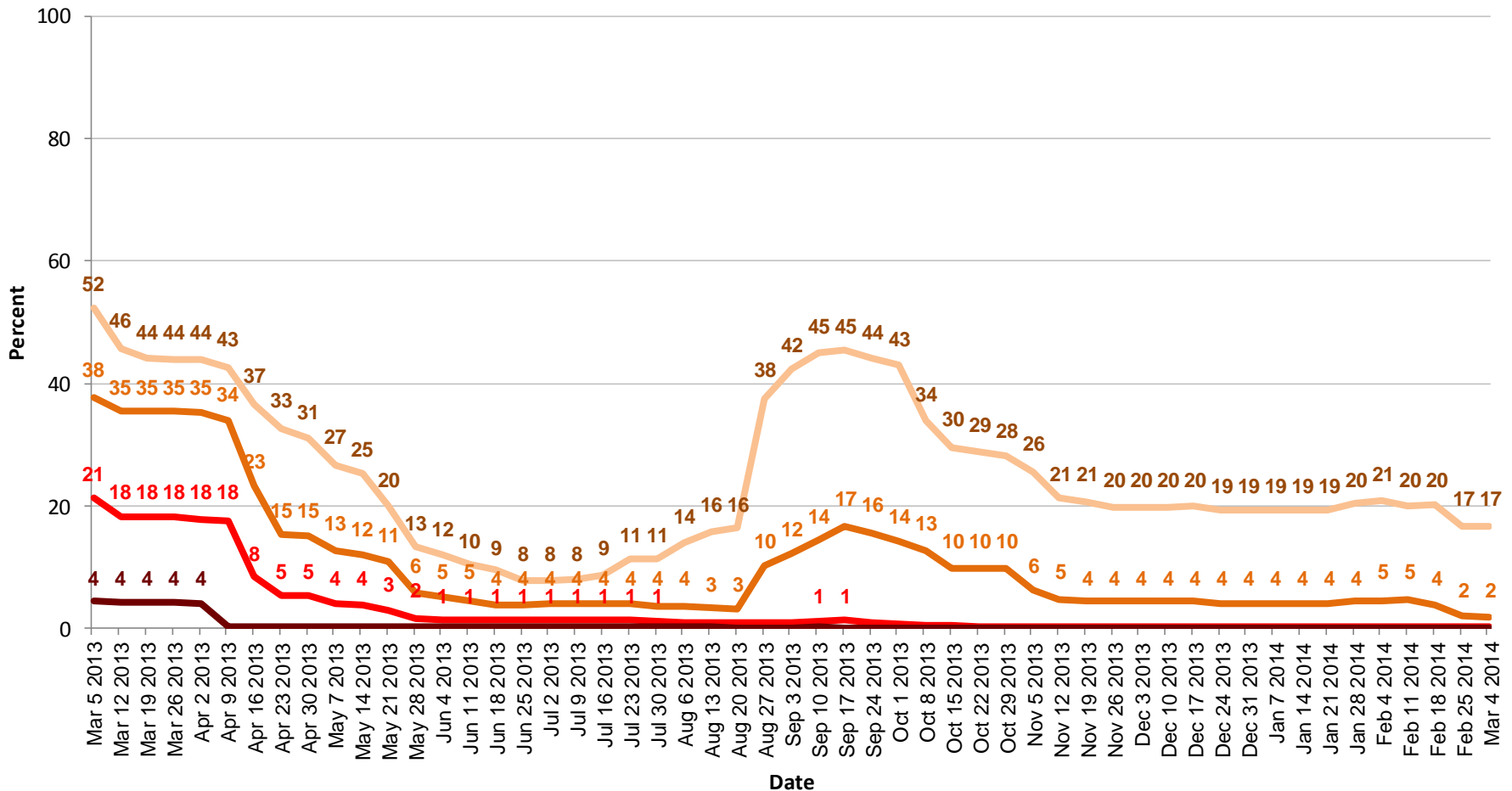

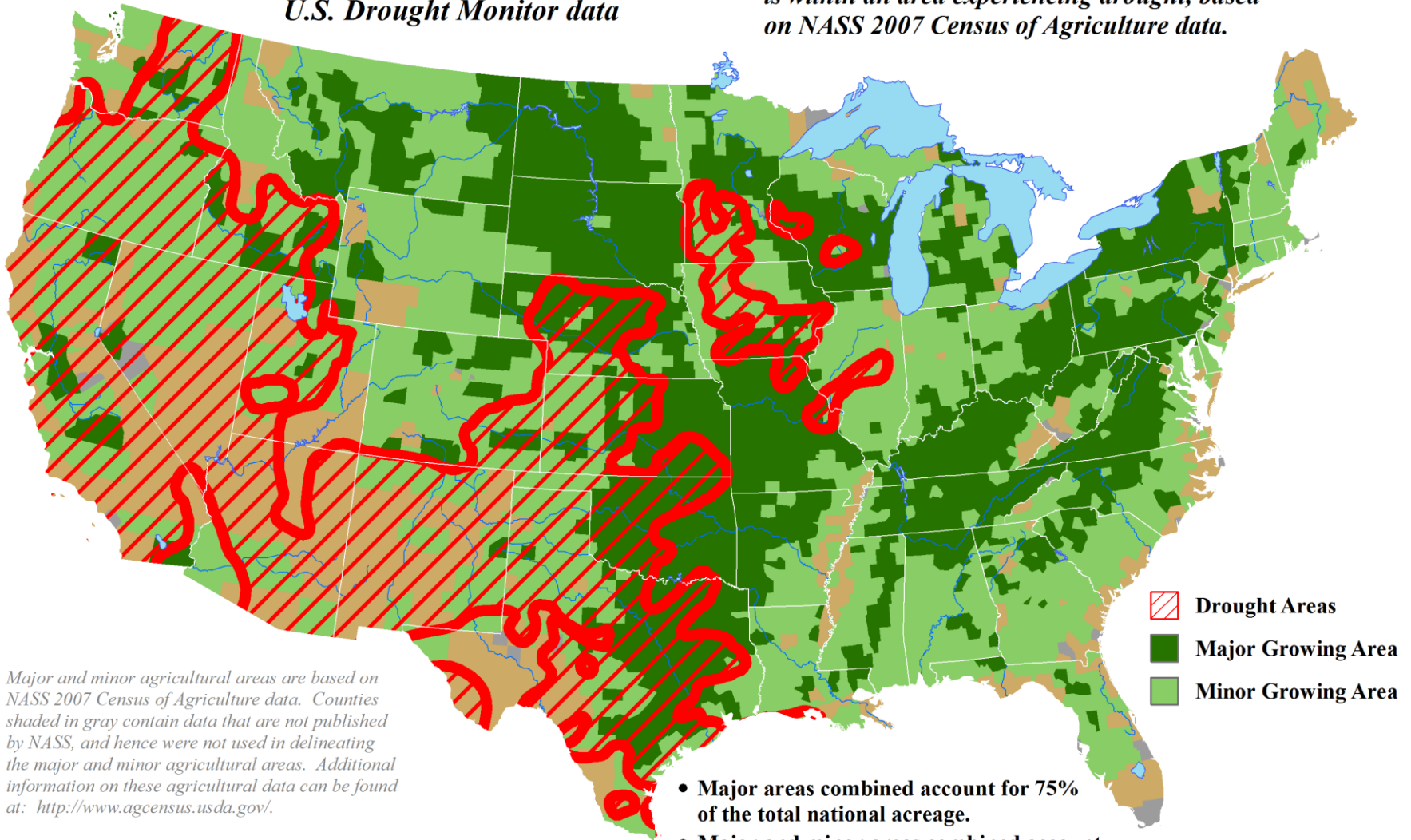

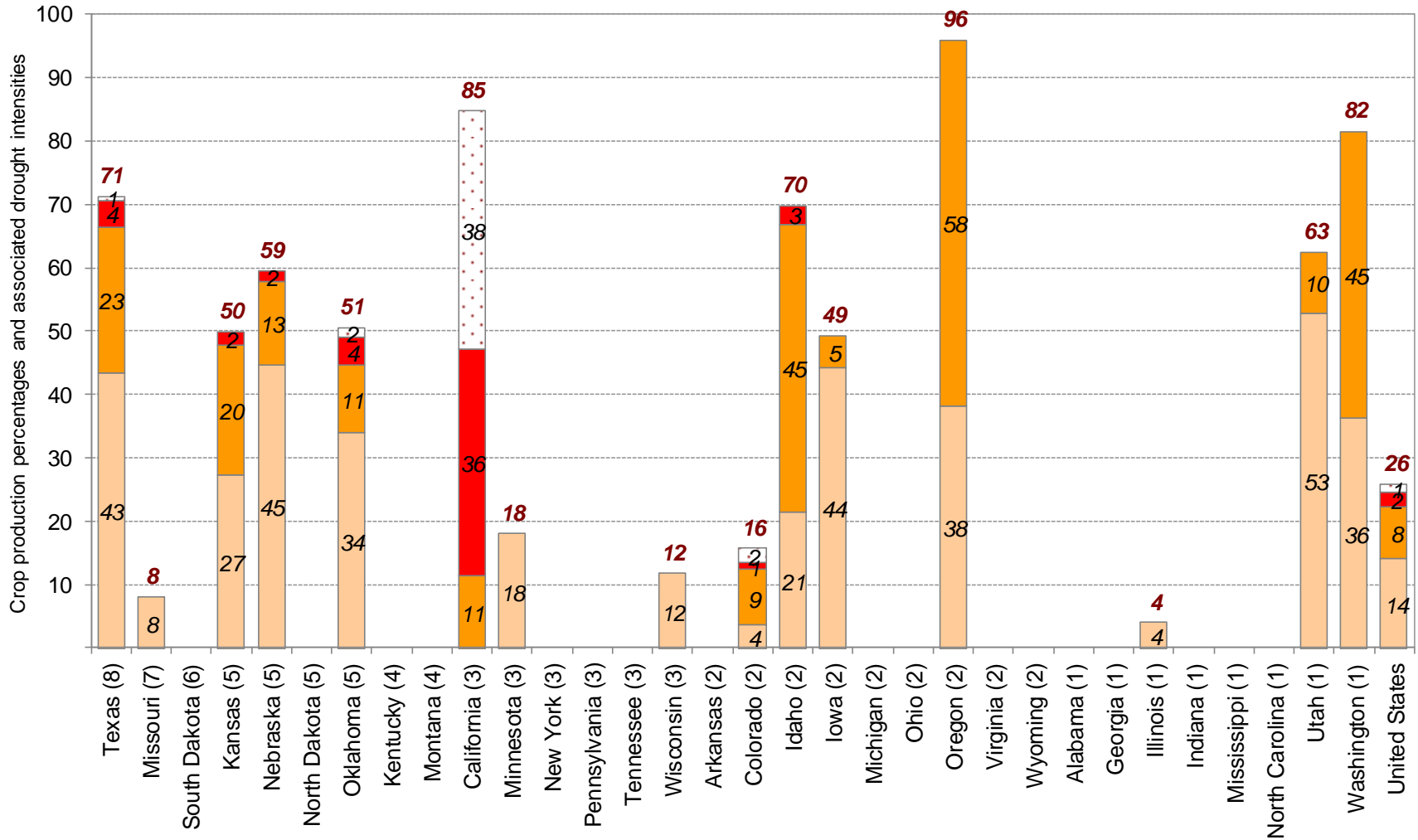

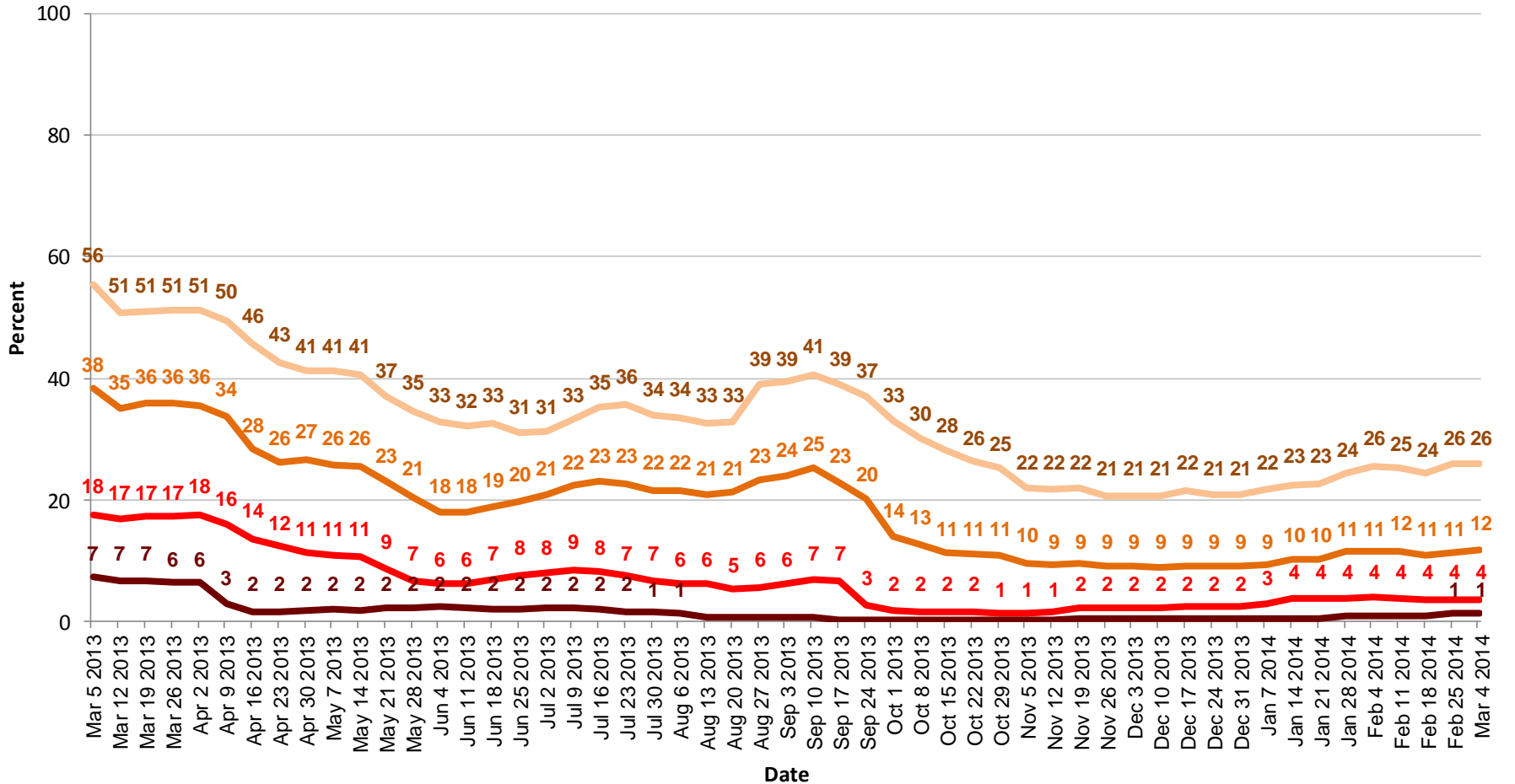

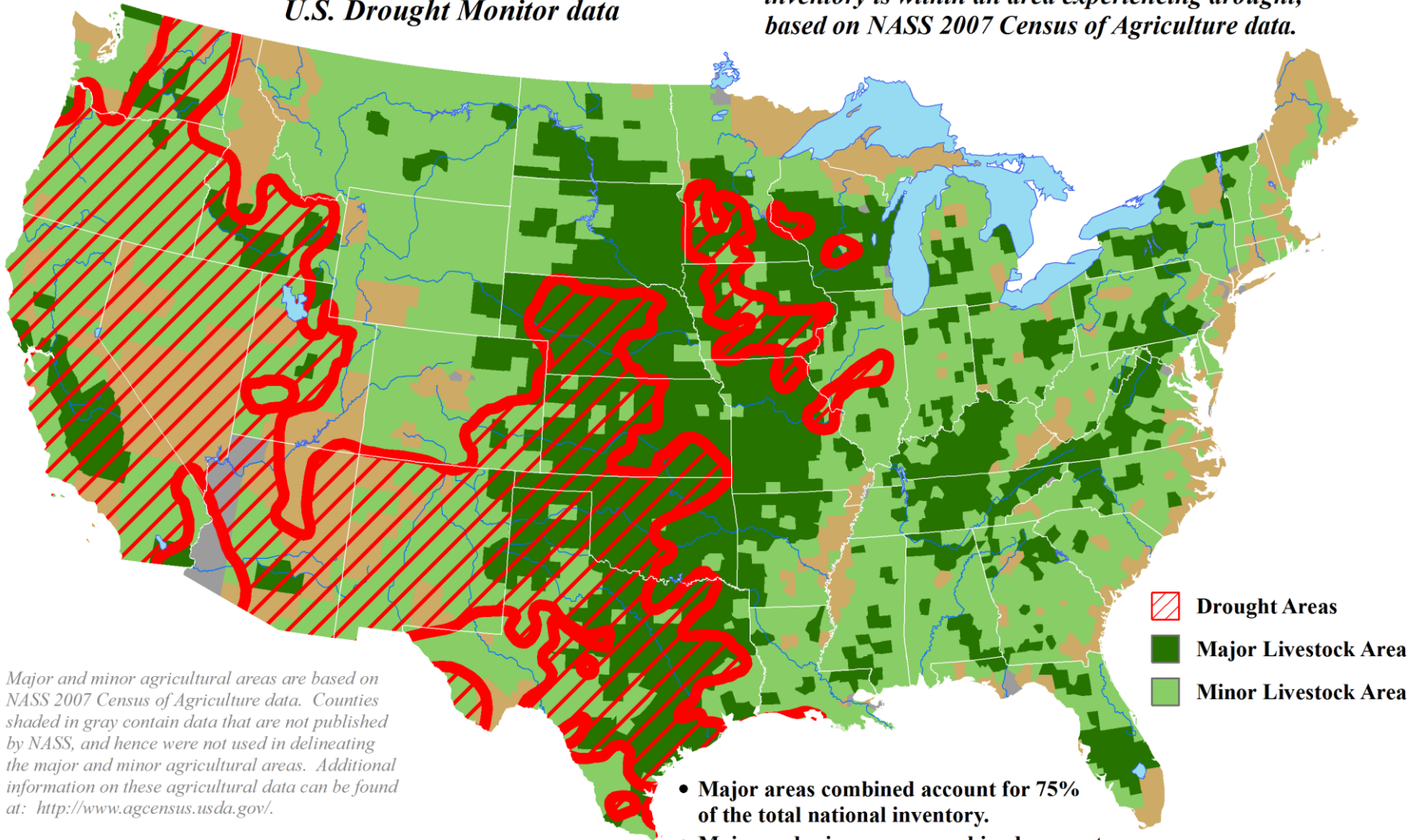

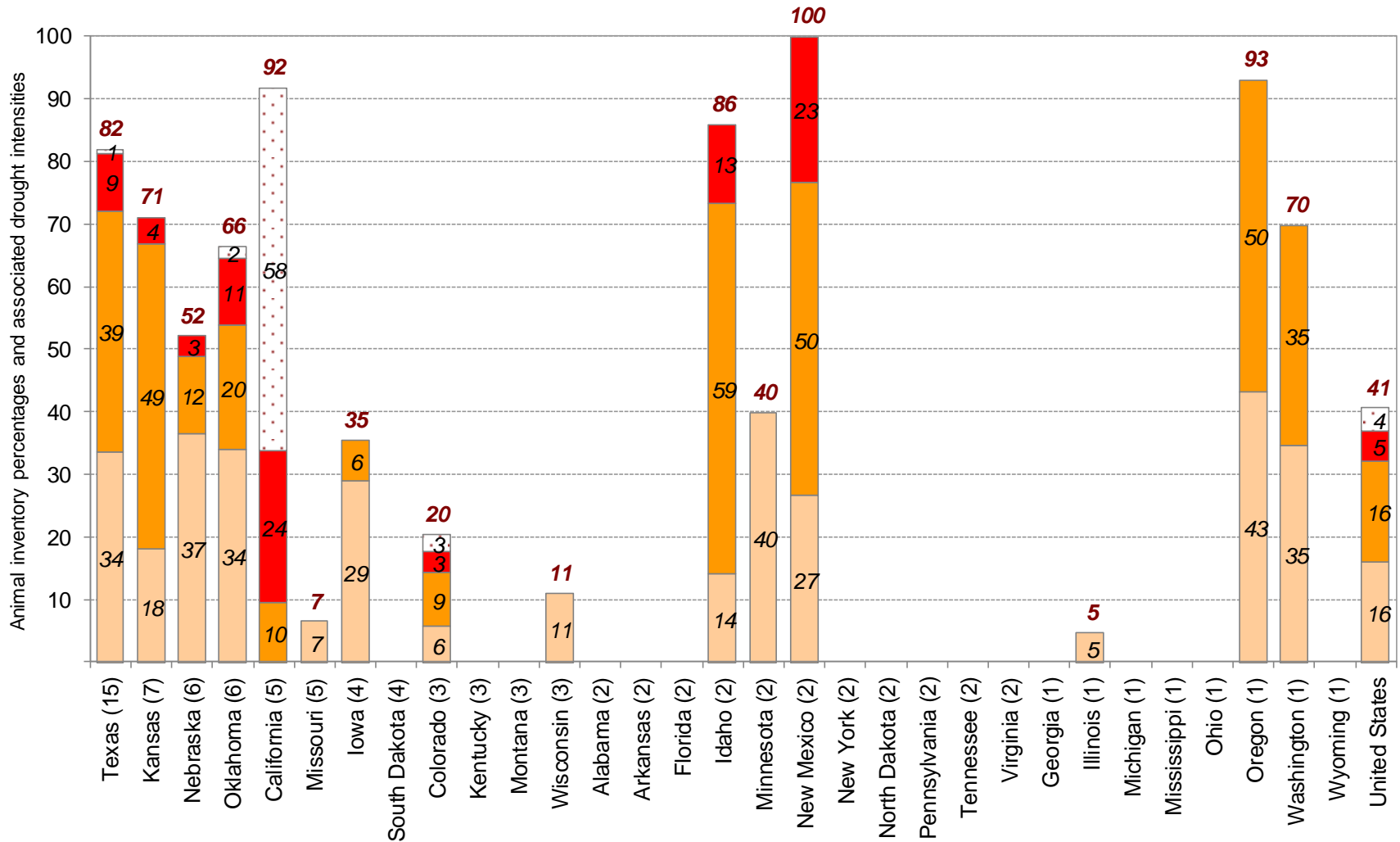

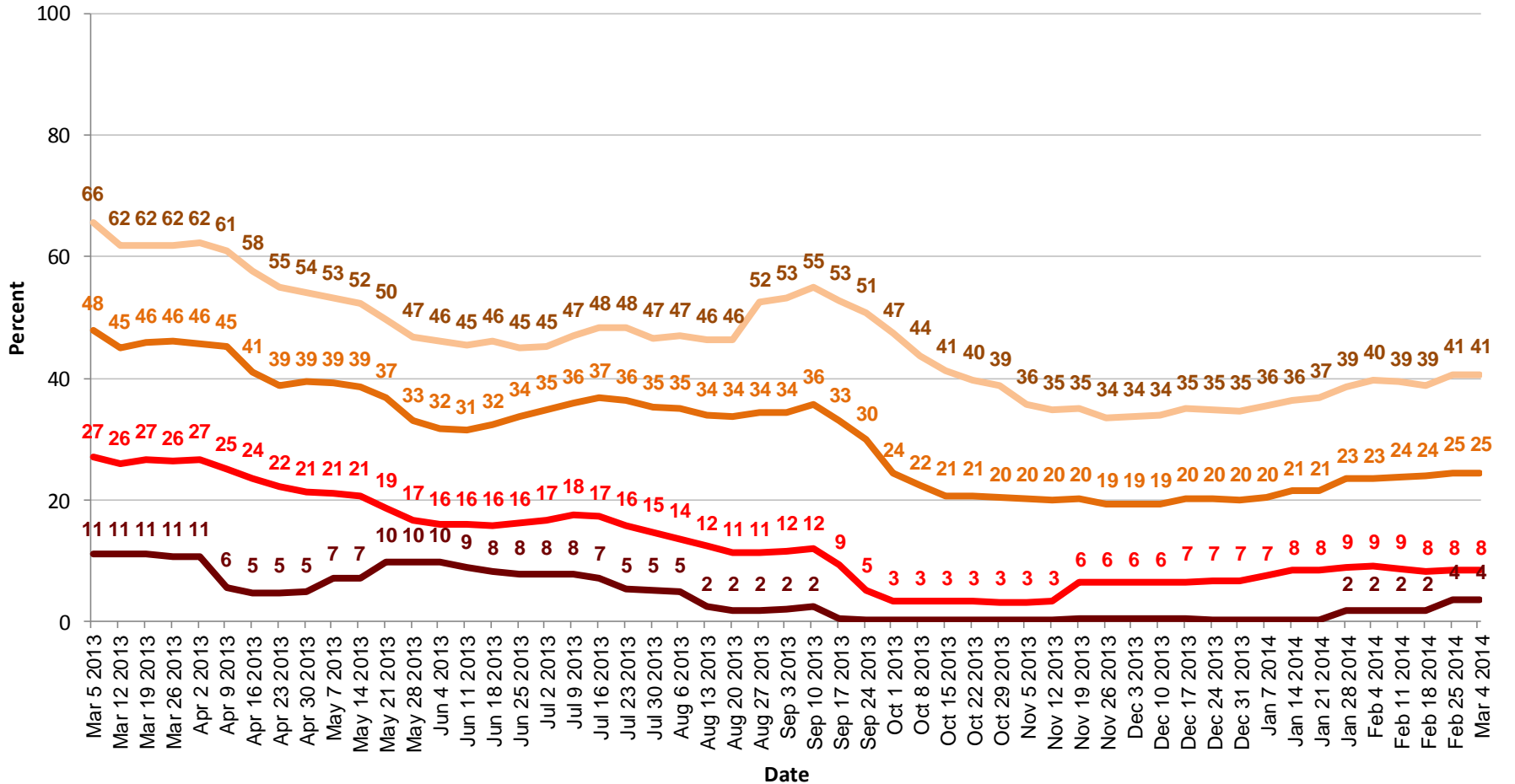

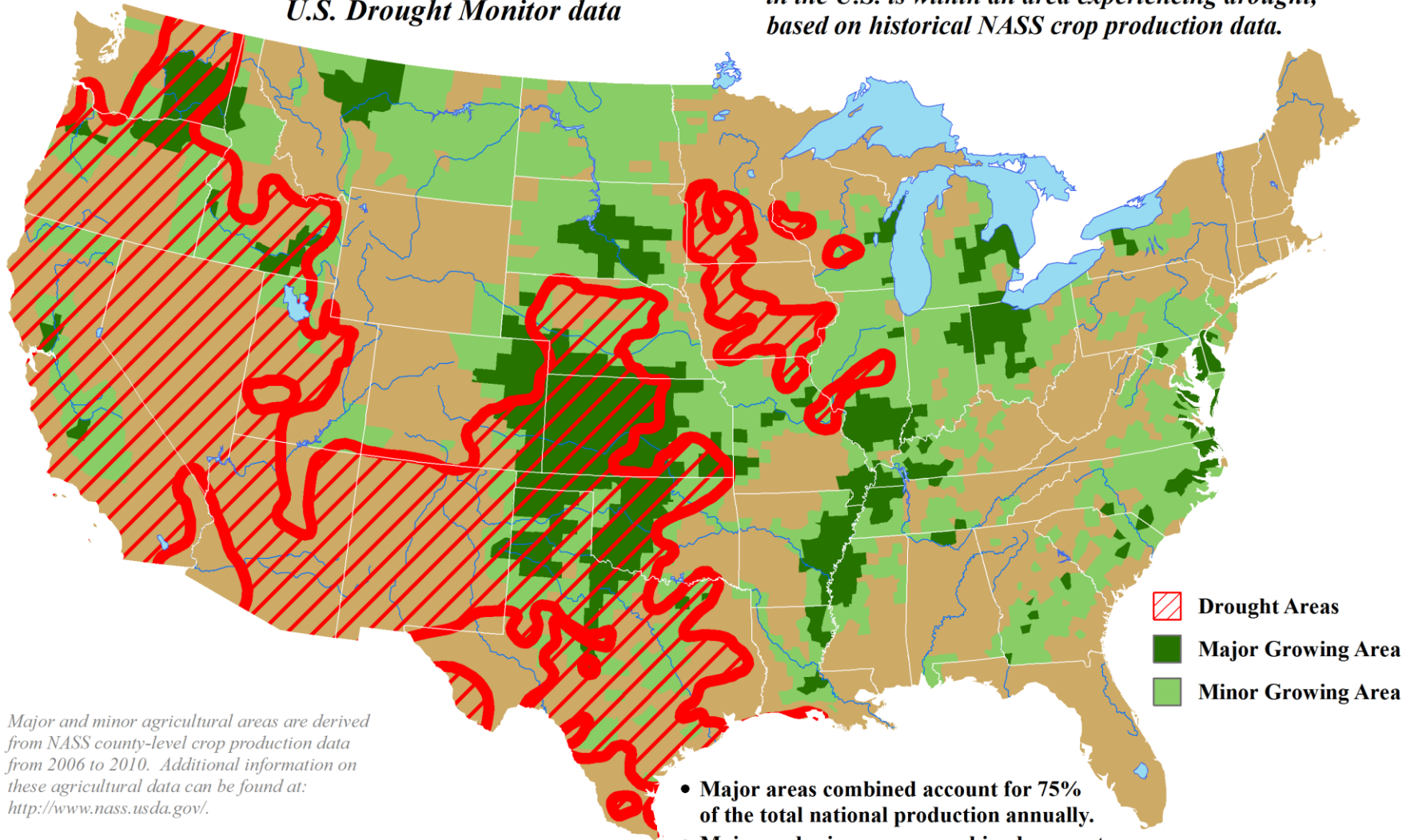

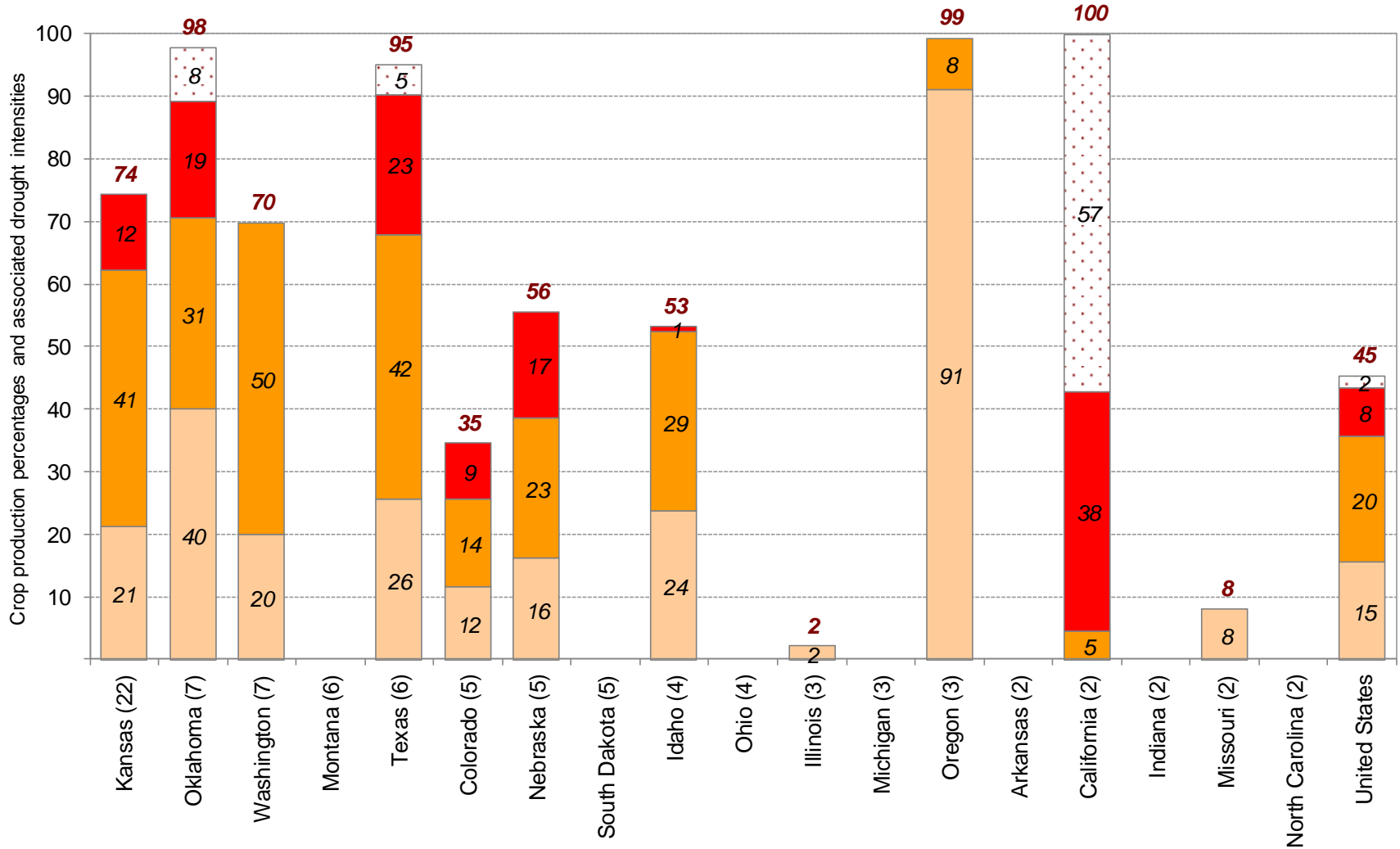
