One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtanker and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 146th Airlift Wing (California Air National Guard) have been deployed to support wildland fire operations in California.

Area Command Team (Jalbert) has been mobilized to Northern California to support COVID-19 mitigation planning and the mobilization of international personnel.

**CZU Aug Lightning Complex** (4 fires), San Mateo-Santa Cruz Unit, Cal Fire. IMT 1 (Cal Fire Team 3). Eight miles east of Pescadero, CA. Timber, brush and closed timber litter. Active fire behavior with backing, creeping and smoldering. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**LNU Lightning Complex** (3 fires), Sonoma-Lake Napa Unit, Cal Fire. IMT 1 (Cal Fire Team 2). Two miles north of Barro, CA. Chaparral, tall grass and timber. Active fire behavior with uphill runs, torching and flanking. Numerous structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**SCU Lightning Complex** (2 fires), Santa Clara Unit, Cal Fire. IMT 1 (Cal Fire Team 6). Five miles southwest of Brentwood, CA. Tall grass and chaparral. Active fire behavior with wind-driven runs, isolated torching and smoldering. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

**North Complex** (2 fires), Plumas NF, USFS. IMT 1 (CA Team 1). IMT 1 (CA Team 4) mobilizing. IMT is also managing the Sheep fire. One mile southwest of Crescent Mills, CA. Timber, short grass and brush. Active fire behavior with flanking, single tree torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Sheep**, Plumas NF, USFS. IMT 2 (CA Team 10) mobilizing. Thirteen miles east of Westwood, CA. Timber, short grass and chaparral. Active fire behavior with spotting, flanking and single tree torching. Numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**August Complex** (6 fires), Mendocino NF, USFS. IMT 1 (SA Blue Team). Fourteen miles northwest of Elk Creek, CA. Timber, brush and medium slash. Active fire behavior with flanking, running and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Butte/Tehama/Glenn Complex** (7 fires), Butte Unit, Cal Fire. IMT 1 (Cal Fire Team 4). Two miles northwest of Oroville, CA. Timber, brush and tall grass. Active fire behavior with group torching. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**W-5 Cold Springs**, Northern California District, BLM. IMT 2 (CA Team 13). Eleven miles east of Madeline, CA. Timber and brush. Active fire behavior with uphill runs, wind-driven runs and long-range spotting. Structures and sage-grouse habitat threatened. Area, road and trail closures in effect.

**Woodward**, Point Reyes National Seashore, NPS. IMT 1 (NR Team 2). Three miles southwest of Olema, CA. Timber, brush and chaparral. Active fire behavior with uphill runs, isolated torching and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Red Salmon Complex** (2 fires), Six Rivers NF, USFS. IMT 2 (GB Team 5). Fourteen miles northeast of Willow Creek, CA. Timber, chaparral and short grass. Active fire behavior with uphill runs, flanking and torching. Structures threatened. Area, road and trail closures in effect.

**Dolan**, Los Padres NF, USFS. IMT 1 (CA Team 2). IMT 1 (PNW Team 2) mobilizing. Ten miles south of Big Sur, CA. Timber, brush and chaparral. Moderate fire behavior with short-range spotting, isolated torching and

flanking. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Lake**, Angeles NF, USFS. IMT 2 (CA Team 14). Seventeen miles west of Lancaster, CA. Timber, brush and chaparral. Minimal fire behavior with creeping and smoldering. Numerous structures and energy infrastructure threatened. Area and trail closures in effect.

**SQF Complex** (2 fires), Sequoia NF, USFS. IMT 2 (CA Team 12). IMT 1 (NR Team 1) mobilizing. Thirty-three miles east of Porterville, CA. Timber and short grass. Active fire behavior with long-range spotting, wind-driven runs and group torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**River**, San Benito-Monterey Unit, Cal Fire. IMT 1 (Cal Fire Team 1). IMT is also managing the Carmel fire. Five miles southeast of Salinas, CA. Brush, chapparal and short grass. Minimal fire behavior with creeping and smoldering.

**Carmel**, San Benito-Monterey Unit, Cal Fire. Three miles southeast of Carmel Valley, CA. Brush, tall grass and chapparal. Minimal fire behavior with creeping and smoldering.

**Predictive Services Discussion:** A secondary front will drop south into the Northern Rockies from Alberta bringing scattered, wet, strong storms to Montana, Idaho, and Wyoming. A cool, dry, but gusty northerly flow will develop over the Great Basin and will lead to critical conditions across southern Utah and southern Nevada. The monsoonal surge of moisture over the southwest will begin to move further east into New Mexico, Colorado, and West Texas while diminishing across Arizona. A strong ridge of high pressure will begin to strengthen off the coast of the Pacific Northwest and northern California. The offshore winds across northwestern California will begin to weaken in the afternoon as the ridge extends its reach into the state. In the East, expect another day of scattered storms as a weak frontal boundary stalls along the Atlantic and Gulf Coasts.

## Unburned Fuel Between You And The Fire

*Operational Engagement Category*

It is important for firefighters to recognize unburned fuel between themselves and the fire as Watchout Situation #11. Often it is not possible or practical for direct attack on a fire. Before attempting indirect attack and any time the firefighter is in a position where there is unburned fuel between them and the fire, the following questions must be addressed immediately:

- Can you see the fire or are you in contact with someone who can? Discuss situations you might find yourself in where you are out in the green and cannot see the fire. What can you do?
- Is fire spread in a direction away from you? Do you consider the potential for fire spread? Are you safe if the wind switches?
- Will your position be defensible when the fire reaches you? Talk about what must be taken into account when building indirect line or approaching a fire through the green.
- Is your line anchored? Discuss how you anchor indirect line.
- Are your escape routes and safety zones adequate? What is adequate?
- Are weather indicators constantly changing?
- To reduce the risks:
  - Post lookouts.
  - Consider a different location. Review situations where you constructed indirect line or approached a fire through the green and how you provided for your safety.
